DEFAULT JUDGMENT ENTRY AND ORDER

This cause came to be heard upon Plaintiff's Motion for Default Judgment

Against Defendants Christopher Sydlo and Bear Transmissions pursuant to Civil Rule

55(A). Defendants were properly served and have failed to defend against this motion or
file an Answer before the Court. The Court finds the motion well taken and hereby
grants and sustains Plaintiff's Motion for Default Judgment. The Court, based on that
motion and Plaintiff's Complaint, and the affidavits presented at hearing, hereby renders
the following Default Judgment Entry and Order.

FINDINGS OF FACT

- Defendant Christopher Sydio is an individual who at all times relevant herein, operated Bear Transmissions, Inc.
- Defendant Sydlo and Bear Transmissions Inc. solicited consumers for automobile transmission parts and services from Bear Transmissions Inc. location in Newburgh Heights, Cuyahoga County, Ohio.
- 3. Defendants accepted money from consumers and failed to provide contracted transmission parts and services to consumers for their automobiles. At all times herein, consumers received and relied upon statements and misrepresentations made by Defendant Sydlo, personally and in writing. Defendant Sydlo allowed, caused or ratified such acts and practiced described above.

CONCLUSIONS OF LAW

- The Court has jurisdiction over the subject matter, issues and parties to this action and venue is proper.
- The business practices of the Defendants as described herein and in Plaintiff's
 Complaint are governed by the Consumer Sales Practices Act, R.C. 1345.01 et seq.
- 6. The Ohio Attorney General, acting on behalf of the citizens of Ohio, and in the best interest of the State, is the proper party to commence this action under the authority of the Ohio Consumer Sales Practices Act, R.C. 1345.07, and by virtue of his authority to protect the interest of the citizens of the State of Ohio.
- 7. Defendants are "suppliers", as that term is defined in R.C. Section 1345.01(C), as

Defendants are engaged in the business of effecting "consumer transactions" by offering automotive transmission parts and services for a fee, within the meaning of R.C. Section 1345.01(A).

8. Defendants have committed unfair and deceptive acts or practices in violation of the Consumer Sales Practices Act, R.C. 1345.02(A) and the Ohio Administrative Code 109:4-3-09, by accepting money from consumers for goods and services and failing to make full delivery or a refund.

WHEREFORE, this Court ORDERS that:

- A. Each act or practice of which Plaintiff complains violates the Ohio Consumer Sales

 Practices Act in the manner set forth in the Complaint.
- B. Defendant Sydlo is PERMANENTLY ENJOTNED from engaging in the acts or practices in violation of the Ohio Consumer Sales Practices Act, R.C. 1345.01 et seq.
- C. Defendant Sydlo is PERMANENTLY ENJOINED from engaging in business in the State of Ohio as a supplier until all judgment ordered remuneration is paid, including any outstanding unsatisfied judgment arising out of a prior consumer transaction; and is further enjoined from engaging in the acts and practices of which Plaintiff complains.
- D. Defendant Sydlo is ORDERED to maintain in his possession and control for a period of five (5) years all business records relating to Defendant's solicitation or effectuation of business in Ohio and to permit the Ohio Attorney General or his representative, upon reasonable, twenty-four (24) hour notice, to inspect and/or copy any and all of said records, however stored, and further are ORDERED that copies of such records be provided at Defendant's expense to the Ohio Attorney General upon

- request of the Ohio Attorney General or his representatives;
- E. Defendants are jointly and severally liable for consumer restitution in the amount of Seven Thousand Five Hundred and Eighty Five Dollars (\$7,585.00). Payment(s) shall be made to the Office of the Ohio Attorney General ("Attorney General"), to be distributed by the Attorney General in his sole discretion. The Attorney General will distribute this payment to individual consumers. Any remaining amount not distributed to consumers will revert to the Ohio Consumer Protection Enforcement Fund. Payment(s) shall be made by delivering a certified check or money order within 30 days of the date of this entry, made payable to the "Ohio Attorney General," to:

F. Defendant Sydlo is assessed civil penalties in the amount of Fifteen Thousand Dollars, (\$15,000.00). Payment(s) shall be made by delivering a certified check or money order within 30 days of the date of this entry, made payable to the "Ohio Attorney General," to:
