FINAL ENTRY AND ORDER GRANTING JUDGMENT AGAINST DEFENDANTS

Defendants.

Plaintiff, the State of Ohio, ex rel. Attorney General Dave Yost ("Plaintiff") commenced this action on November 1, 2023, by filing its Complaint against Defendants Jerricha Richardson and Crownme Coil Care LLC dba Arcani Coil Care ("Defendants"). The Complaint alleged violations of the Ohio Consumer Sales Practices Act ("CSPA"), R.C. 1345.01 *et. seq.* and its Substantive Rules, O.A.C. 109:4-3-01 *et seq.* and sought declaratory relief, injunctive relief, restitution to injured consumers, and civil penalties.

On March 15, 2024, this Court rendered default judgment in favor of the Plaintiff. Default Judgment included an order for Defendant to pay civil penalties and restitution to all consumers injured by Defendant's conduct, in an amount to be determined at a later date via affidavits. Plaintiff filed its Memorandum in Support of Damages and Civil Penalties Against Defendants ("Damages Memo") on April 17, 2024, in which Plaintiff submitted evidence supporting the amount of civil penalties and consumer damages requested. Plaintiff filed a Supplemental Memorandum in Support of Additional Consumer Damages filed on May 9, 2024, with evidence

supporting the consumer damages for consumers identified following the filing of the Damages Memo.

Plaintiff submitted evidence, including the affidavit of an investigator, supporting its request for consumer damages and civil penalties. The evidence established that each of the consumers sustained monetary damages in connection with Defendants' sale of haircare products and related goods. The court finds that the consumers sustained damages in the total amount of \$7,311.53.

In its Damages Memo, Plaintiff also justified the basis for the amount of civil penalties requested pursuant to R.C. 1345.07(D). Plaintiff provided evidence of Defendant's violations of the CSPA which, pursuant to R.C. 1345.07(D), permit the imposition of a civil penalty in the amount of at least \$25,000. The court finds Plaintiff's request well-taken.

Based on the above, the Court restates below the Findings of Fact, Conclusions of Law, and Orders that were originally included in the Court's March 15, 2024 Default Judgment Entry and Order Against Defendants, and orders additional relief based on the evidence present in the Plaintiff's Damages Memo.

FINDINGS OF FACT

- CrownMe Coil Care, LLC is an Ohio limited liability corporation registered with the Ohio Secretary of State.
- 2. Arcani Coil Care is a registered trade name of CrownMe Coil Care, LLC.
- 3. Defendant Richardson does business as CrownMe Coil Care, LLC and Arcani Coil Care.
- Defendant Richardson is a natural person who resides at 2326 Cheviot Hills Lane, Vandalia,
 OH 45377.
- 5. Defendant CrownMe Coil Care, LLC, doing business as Arcani Coil Care, has represented that its place of business was a storefront salon located at 2809 Philadelphia Dr., Dayton, OH 45405. The address registered with the Ohio Secretary of State is 4626 Natchez Dr., Dayton,

- OH 45416. Defendant Richardson operates the business solely from her home address at this time.
- 6. Defendant Richardson directed, supervised, approved, formulated, authorized, ratified, benefited from, and/or otherwise participated in the acts and practices of CrownMe Coil Care, LLC and Arcani Coil Care, as described in the Complaint.
- 7. At all times relevant to this action, Defendants were engaged in the business of soliciting, offering for sale, or selling hair care products.
- 8. Defendants sold hair products through online forums.
- Defendant Richardson personally formulated, made, packaged, labeled and prepared for shipping the hair care products Defendants offered for sale online.
- 10. Defendants engaged in the online solicitation of hair care products, and related goods and services using the registered name Arcani Coil Care.
- Defendants entered into online agreements with consumers for the purchase of hair care products and related goods and services.
- 12. Defendants accepted money from consumers for the purchase of hair care products.
- 13. After accepting money from consumers for the purchase of hair care products, Defendants failed to deliver the hair care products to some consumers.
- 14. Some consumers who had hair care products shipped to them found that the product was delivered to them with an inaccurate amount contained therein.
- 15. Some consumers who had hair care products shipped to them found the product contained mold, or developed mold shortly after being opened.
- Defendant Richardson admitted to the State that she prepared and packaged product for approximately 90 consumers that were not given adequate time for the product to cool before closing the container and preparing the containers for shipment and delivery.

- 17. Defendants did not provide substitute product to the consumers who did not receive the order product or those whose product contained mold.
- 18. Some consumers who did not receive the ordered hair care products requested refunds from Defendants.
- 19. Defendants did not provide refunds to consumers to whom they did not deliver the promised hair care products.
- Some consumers who received incorrect or moldy hair care products requested refunds from Defendants.
- Defendants did not provide refunds to consumers that received incorrect or moldy hair care products.

CONCLUSIONS OF LAW

- 22. Jurisdiction over the subject matter of this action lies with this Court pursuant to R.C. 1345.04 of the Consumer Sales Practices Act, R.C. 1345.01, et seq. ("CSPA").
- 23. This Court has venue to hear this case pursuant to Ohio Civ. R. 3(C)(1)-3(C)(3), in that Montgomery County is where Defendant Jerricha Richards resides, where the Defendants' principal place of business was located, and where the Defendants conducted some of the activity that gave rise to the claim for relief.
- 24. The Attorney General is the proper party to commence these proceedings in the public interest and on behalf of the State of Ohio under the authority vested in him by R.C. 1345.01 et seq.
- Defendants are "suppliers" as that term is defined in R.C. 1345.01(C) of the CSPA because, at all times relevant herein, Defendants engaged in the business of effecting "consumer transactions" by soliciting and selling goods or services to individuals for purposes that were primarily personal, family, or household, within the meaning of R.C. 1345.01(A).

- 26. Defendants engaged in unfair or deceptive acts or practices in violation of the CPSA, R.C. 1345.02(A) and R.C. 1345.02(B)(2), by representing that the Defendants' hair care products are of a particular standard, quality, grade, style, prescription or model, that they are not. Specifically, Defendants failed to provide products that were as represented, either in the correct amount provided on the product label, and/or by failing to provide a product that was of the quality represented.
- 27. Defendants engaged in unfair or deceptive acts or practices in violation of the CPSA, R.C. 1345.02(A), and the Failure to Deliver Rule, O.A.C. 109:4-3-09(A), by accepting money from consumers for goods or services, failing to make full delivery of the promised goods or services within eight weeks, failing to provide full refunds, advising the consumers of the duration of an extended delay and offering to send a refund within two weeks if so requested, or furnishing similar services of equal or greater value as a good faith substitute.
- 28. The acts or practices described above in the paragraphs above have been previously determined by Ohio courts to violate the CSPA. Defendants committed said violations after such decisions were available for public inspection pursuant to R.C. 1345.05(A)(3).

ORDER

For the purposes of effecting this Final Judgment Entry and Order, it is hereby ORDERED, ADJUDGED, and DECREED that:

- A. Plaintiff's request for Declaratory Judgment is GRANTED, and it is therefore DECLARED, pursuant to R.C. 1345.07(A)(1), that the acts and practices set forth above violate the CSPA and its Substantive Rules, O.A.C. 109:4-3-01 *et seq.*, in the manner set forth herein.
- B. Defendants, doing business under their own names or any other names, together with their agents, employees, successors or assigns, and all persons acting in concert and participation with them, directly or indirectly, through any corporate device, partnership, or other association, are hereby PERMANENTLY ENJOINED, pursuant to R.C. 1345.07(A)(2),

- from engaging in any unfair, deceptive, or unconscionable acts and practices that violate the CSPA, or its Substantive Rules including, without limitation, the conduct described in the Conclusions of Law.
- C. Defendants are ORDERED, jointly and severally, pursuant to R.C. 1345.07(B), to pay damages to all consumers injured by their conduct in the amount of \$7,311.53 to be paid to the Attorney General's Office and distributed to the consumers as specified on the attached Addendum A (Exhibits A and B).
- D. Based on the above findings that Defendants committed unfair and deceptive acts and practices in violation of the CSPA, Defendants are ORDERED, jointly and severally, to pay a civil penalty to the Attorney General, pursuant to R.C. 1345.07(D), in the amount of \$25,000.
- E. The \$32,311.53 due to the Attorney General's Office under this Judgment shall be made upon entry of Judgment by delivering a certified check or money order payable to the "Ohio Attorney General's Office" and delivered to:

- F. Defendants are ORDERED to pay Plaintiff collection costs and interest on the unpaid balance of this judgment as permitted by Ohio law.
- G. Defendants are ORDERED to pay all court costs associated with this matter.
- H. Defendants, pursuant to the Court's authority in R.C. 1345.07(B) to grant other appropriate relief, are hereby ENJOINED from engaging in consumer transactions as suppliers in the State of Ohio until all monetary amounts ordered to be paid in this action have been satisfied.

THIS IS A FINAL APPEALABLE ORDER, AND THERE IS NO JUST REASON FOR DELAY FOR PURPOSES OF CIV.R. 54. IN ACCORDANCE WITH APP.R. 4, ANY PARTY INTENDING TO APPEAL THIS DECISION SHALL FILE A NOTICE OF APPEAL WITHIN THIRTY (30) DAYS.
